The Baltic Journal of Political Science

The Baltic Journal of Political Science is a peer-reviewed scholarly journal published by the Institute of International Relations and Political Science of Vilnius University. The journal geographically focuses on the Baltic Sea area (and more particularly on the Baltic states) and provides a platform for theoretical and empirical research papers and book reviews of researchers, academicians, professionals, and promising students on political theory, comparative politics, international relations and public policy. The journal aims to sustain a wide profile of scientific publications delivering rigorous analytical insights into contemporary political phenomena in the region and to be ranked as a regular and high-quality academic periodical. The BJPS reaches out for academic community and political practitioners and offers ample opportunities for scholarly visibility and potential impact. The journal welcomes article proposals and book reviews related to different facets of the aforementioned scientific fields of political science and thematically similar disciplines. Proposals undergo a blind peer-review process (two anonymous reviewers) by scholars established in their respective fields. Authors and co-authors will receive a copy of the journal with their article. The journal is published in print version.

The *Baltic Journal of Political Science* welcomes relevant submissions of 6000 to 8000 word articles which include an abstract of 100 to 150 words. Each submission should include the full name, academic title, position, institution, and address of the author (or authors, for manuscripts with multiple authors).

STYLE AND FORMATTING GUIDELINES

Submitted articles should follow the editorial style and formatting guidelines listed below:

- ♦ All articles should be typed in twelve point size Calibri font with 1.5 line spacing.
- ♦ Articles should have an (unnumbered) introduction and conclusion.
- ♦ Article chapters should be numbered in Arabic numerals. If necessary, a chapter may be divided into sub-chapters: 1.1, 1.2, 1.3.
- ♦ Relevant tables, figures, and diagrams may be inserted in the text, numbered consecutively with titles above the table, figure, or diagram.
- ♦ The *Baltic Journal of Political Science* follows the 5th edition of the Harvard System of Referencing.
- ♦ Per Harvard, references and citations should be indicated within the text, with a full list of all cited references, listed alphabetically at the end of the article.
- ♦ Per Harvard, *exact page references should be provided when possible*. Indirect references should appear as: (*Cormack, 1994, pp. 32–33*). Direct references should appear as: *Lawrence (1996, p. 124) states that . . .*
- ♦ With the exception of the Harvard System of Referencing, the *Baltic Journal of Political Science* follows the 16th edition of the *Chicago Manual of Style* and the *Oxford Dictionary* for spelling and hyphenation.
